### LYNCHBURG DISTRICT TRAFFIC ALERT April 14-20, 2025

### District-wide activities:

Crews will perform various activities throughout the district to include, but are not limited to bridge & guardrail maintenance, brush/tree/limb cutting, pothole/surface/shoulder work, surface treatment/paving operations, work orders, mowing, boom axing, drainage repairs/ work and roadside cleanup.

# Work at specific locations:

Amherst County: Please note district-wide activities above.

**Appomattox County:** 

<u>Route 613 (Spring Grove Rd.)</u> - Bridge Replacement. Closed to through traffic between Route 647 and Route 608 from February 10 to mid-April, 2025. **Please note district-wide activities above.**

### Charlotte County:

<u>Route 40 (David Bruce Avenue) and Route 47 (Legrande Avenue)</u> - Replacement of sidewalk and ADA ramps in town of Charlotte Court House beginning March 24, 2025. Sidewalk closures and lane closures expected. Use caution. *Estimated completion April 16, 2025.*

## **Cumberland County:**

<u>Route 673 (Ligontown Rd.)</u> - Bridge Rehabilitation. Closed from Guinea Road to River Road. Estimated completion mid-May, 2025. **Please note district-wide activities above.** 

## Halifax County:

<u>Route 615 (Dudley Road)</u> - Bridge Replacement. Closed to through traffic. Detour is in place. Estimated completion April 2025.

Please note district-wide activities above.

## Lynchburg:

<u>Rte. 501 (Campbell Avenue) over Route 29/460 Bypass(Richmond Highway)</u> - Bridge maintenance work. Traffic will be reduced to one lane with left lane closed for Route 501 (Campbell Avenue) northbound traffic beginning the week of April 14, 2025. Use caution. Estimated completion April 30, 2025.

<u>Route 128 (Candlers Mountain Road)</u> - Bridge Rehabilitation (over Norfolk Southern Railroad) to begin May 18, 2025. Expect alternating lane closures. Expected completion July 1, 2025. **Please note district-wide activities above.** 

### Nelson County:

<u>Route 653 (Wilson Road</u>) - Bridge Replacement. The bridge over the Norfolk Southern Railroad is closed. Estimated reopening November 2025. **Please note district-wide activities above.** 

### Pittsylvania County:

<u>Route 311 (Harville-Saunders Parkway)</u> - New Road Construction. The roadway is open. Work is still being done off the roadway. Expect shoulder and lane closures. Overall completion expected June 16, 2025.

### Prince Edward County:

<u>Route 639 (Arvon Road)</u> - Bridge Closure over Hunts Creek. No through traffic. Estimated completion June, 2025.
